#### Flexi Payment Scheme

Flexi payment scheme is to assist students who have difficulty in cash flow; this payment scheme allows students to pay the total course fee by installments to ease the cash flow pressure on students. Please refer to FAME Course Consultants for further details. The Flexi Payment Scheme has to be applied and it is subject to approval on a case-to-case basis.

#### Scholarship

Scholarships bring special financial assistance to students. There are various scholarships available from time to time according to the announcement of the college. Please refer to our Course Consultants for the latest Scholarship plans available. Application is required and is subject to approval on a case-to-case basis.

#### PTPTN (Malaysian only)

The PTPTN Education Loan Scheme was set up by the government with the aim of providing education loans to students pursuing their studies in local institutions of higher learning (IPT). This loan will enable students to fully or partially pay their fees and their subsistence for the duration of their studies in FAME. Applicants will need to fulfill the course entry requirement in order to be eligible for this educational loan.

#### EPF Withdrawal (Malaysian only)

This scheme allows students or parents who are qualified EPF members (Malaysia citizen) to withdraw their savings from the second account to finance either their studies or their children's studies. The purpose is to finance education fees which includes tuition fees, examination fees, registration fees and etc.


